FINAL EVALUATION OF ITEMS COMING INTO DIRECT CONTACT WITH DRINKING WATER

In accordance with Section 5 of Act No. 258/2000 Coll., as amended, on the protection of public health, you have requested verification of the health safety of the product: Pressure vessel C2B, manufacturer: Global Water Solutions Ltd. (GWS), 5th floor, 37 Esplanade St. Helier, Jersey, JE1 2TR, Islands.

The product in question is intended for the distribution of drinking water and is designed for direct and short-term contact with drinking water.

This product consists of a pipe fitting - PVC, an insert - polypropylene, and a membrane - butyl rubber 6038, identical in composition and manufacturer to the already tested pressure vessels of the GSW FlowThru series, which have already been assessed for health safety for contact with drinking water in accordance with the requirements of Act No. 258/2000 Coll. and Decree No. 409/2005 Coll., as amended, on the hygienic requirements for products in direct contact with water and for water treatment, and a positive expert assessment of health safety has been issued.

Based on the verification and examination of the submitted documentation, review of the scope of the established indicators according to the applicable legislation, and the provision of the following documents, a decision can be made regarding the health safety of the product.

As a basis for preparing the final evaluation of items coming into direct contact with drinking water, the following were submitted:
